Project: Wild Horse Creek Headcut Monitoring, Floyd's to Powder (starting on Floyd's property in Section 17, T52N, R75W, below road going to Twenty Mile Creek)

11/13/06

Left phone messages requesting permission to access private land along Wild Horse Creek with Stephen Hofheimer, Bill Suranyi, Floyd and Dixie Bulkley, Keith Troll, and Ken Clabaugh. I sent Cover Letter and Access Permission Form (appendix B) along with self-addressed stamped envelope to Enriquetta Trustee Service, Riley and Mary Lou Malli, Floyd Land & Livestock, Inc., and Deer Track Ranch LLC. Spoke with Linda at The State Land & Investments Office, and she requested I send Cover Letter and Access Permission Form to Jim Whalen's attention. ||

11/14/06

I received permission to access Steve Hofheimer's property, by phone, from Steve Hofheimer. Access was granted for foot or horseback travel, after leaving message with Randy Jahn, the property caretaker. I mailed Cover Letter and Access Permission Form to Jim Whalen at The State Land & Investments Office.

11/15/06

I mailed Cover Letter and Access Permission Form to Keith Troll, Surnyi Ranch, Inc., Floyd and Dixie Bulkley, and Ken Clabaugh, after 48 hours without having phone messages returned. ||

11/16/06

I received a phone call from Floyd Bulkley granting access to his property, after contacting Alex McNab, prior to accessing their property.

11/29/06

I left a message with Alex McNab (Bulkley Rep.), and Randy Jahn (Hofheimer Rep.), letting them know I would be accessing their properties on 11/30/06 and 12/1/06 to perform headcut monitoring. I also gave them my name, phone number, license plate number, and pick-up description. I also emailed Jim Whalen at The State Land & Investments Office, to see if he had received the Cover Letter and Access Permission form I sent him.

11/30/06

I walked Steve Hofheimer's land in Section 15, T54N, R77W, and found no headcuts of 24" or greater. I also walked Floyd and Mary Lou Bulkley's property in Sections 19 &

20, T54N, R76W, and found no headcuts of 24" or greater. I received the Access Permission Form from Darlene Floyd of Floyd Land & Livestock, Inc., granting permission to access, with 5 days notice. I sent letter to Darlene Floyd notifying her I would be accessing her property the week of 12/11/06.

12/4/06

I received letter from Jim Whalen from The State Lands & Investments Office with rules for survey access, which state that "you must use your best effort to contact the surface lessee(s) and inform them of your intentions to conduct the survey." I called and left message with ken Clabaugh letting him know I would be accessing the State Section he leases on 12/7/06. I left a message with Floyd Land and Livestock, Inc., letting them know I would be accessing the State sections they lease, on 12/7/06.

12/5/06

I received a phone call from ken Clabaugh, denying access across his property to the State Section he leases, and he referred me to his attorney, Tom Toner in Sheridan. I left message at Tom Toner's office in Sheridan, requesting permission to access State Section.

12/7/06

I walked The State Lands & Investment property leased by Floyd Land & Livestock, Inc., in; Section 36, T53N, R76W; Section 1, T52N, R76W; Section 6, T52N, R75W; and BLM Land in Section 6, T52N R75W. I found no headcuts of 24" or greater on any of these properties. I again left a message at Tom Toner's office requesting permission to access State Section leased by ken Clabaugh.

12/12/06

I walked Floyd Land and Livestock, Inc. property in Sections 23, 25, and 26, T53N, R76W. No headcuts of 24" or greater were identified.

12/15/06

I walked Floyd Land & Livestock, Inc. property in Sections 29 & 32, T54N, R76W, and Sections 4 & 5, T53N, R76W. No headcuts of 24" or greater were identified. I left a message with Kandy Sanders, requesting permission to access The Deer Track Ranch LLC property for headcut monitoring. E-mailed Jim Whalen at The State Land & Investments Office, notifying him that ken Clabaugh had refused access across his property to perform headcut monitoring on the State Section he leases (Section 16, T53N, R76W).

12/20/06

I left a message again with Kandy Sanders seeking permission to access The Deer Track Ranch LLC property to perform headcut monitoring. I left a message with Riley and mary Lou Malli seeking permission to access their property to perform headcut monitoring.
