**Request for copy of Application Mine Plan Map**

**Dear Mr. McKenzie,**

**As you are aware from correspondence I have sent to you dated December 5, 2009, I believe that our property, Bush Ranches, will be severely impacted by the proposed expansion which the approval of Croell Redi-Mix's application to the DEQ LQD noted would permit.**

**There is no doubt that our ranch is the property which will be most directly and severely effected if this application is approved by the LQD.**

**On behalf of all of the owners of Bush Ranches, I am attempting to come to terms with the full impact that approval of this application would have on our ranch.**

**I live in Ontario, Canada. I am not able at this time to travel to Sundance to take a firsthand look at the application mine plan map which is currently on display in the Crook County Clerks Office.**

**I have repeatedly been told by LQD staff that it is not possible to send me a copy of the application mine plan map, the reason being that it is too big.**

**The Public Notice regarding this application which was first published in the Sundance Times on October 15, 2009, states the following:**

**"The Wyoming Oil and Gas Commission will be mailed a copy of the application mine plan map as required in W.S. (chapter/section) 36-11-406(j)."**

**If it is possible for the WDEQ LOD to mail this map to the Wyoming Oil and Gas Commission, why is it not possible to mail the same map to a formal protestant to this application. I live at a much greater distance from Sundance than members of the Wyoming Oil and Gas Commission. The DEQ LOD is not requesting that the Wyoming Oil and Gas Commission travel to Sundance in order to take a look at this map.**

**I am once again requesting that a copy of the application mine plan map relating to the Croell Redi-Mix application noted above be sent to me. It would help to facilitate both preparation for and scheduling of the upcoming hearing regarding this matter, if this could be sent to me expeditiously. Regular mail, especially as the holidays approach, can take as long as two weeks to arrive.**
