
**ORDER EXTENDING TIME FOR PUBLIC HEARING**

THIS MATTER came before Dennis Boal the Chairman of the Environmental Quality Council (Council) on November 9, 2009, upon the filing of an objection by Robert and Barbara Musgrave regarding the application of the Laramie County Solid Waste Disposal District for a renewal of and major amendment to their permit to operate a Solid Waste Disposal Facility.

Pursuant to Chapter 1 Section 2(b)(ii)(D) of the Solid Waste Division Rules and Regulations, a public hearing conducted as a contested case proceeding under the Wyoming Administrative Procedures Act, shall be held within (20) days after the last day of the public comment period, unless a different schedule is deemed necessary by the council.

The last day for public comment was October 28, 2009. Twenty days from that date would be November 17, 2009. After review of the Council case load and current meeting schedule the Chairman finds that conducting such a hearing within the 20 day period is not feasible and deems it necessary pursuant to the above referenced rule to set a different schedule for this matter. Therefore, the public hearing in this matter is hereby set for January 14, 2009. The parties will be noticed of the exact time and location of said hearing at a later date.


