JOINT MOTION FOR DISMISSAL

Petitioner PacifiCorp, by and through its counsel of record, and Respondent Wyoming Department of Environmental Quality, Air Quality Division (“DEQ/AQD”), by and through the Wyoming Attorney General’s Office, and pursuant to Wyo. Stat. § 16-3-107(n) and Chapter I, § 11 of the DEQ’s Rules of Practice and Procedure hereby jointly move the Council for an Order approving their Motion to Dismiss.


Wyo. Stat. § 16-3-107(n) and Chapter I, § II of the DEQ's Rules of Practice and Procedure provide for disposition of contested cases by agreed settlement of the parties upon approval of the Environmental Quality Council (the “Council”).

PacifiCorp and DEQ/AQD previously conferred regarding the issues involved in this contested case hearing and arrived at a mutually agreeable settlement, which was accepted by the Council on November 19, 2010. *Order, EQC Docket No. 10-2801*, Nov. 19, 2010. The Council ordered the dismissal of this case and retained limited jurisdiction for the purpose of enabling the parties to alter their Settlement Agreement as a result of changed circumstances. *Id.* at ¶ 6. The parties agree that the changed circumstances described in Section 7 of the Settlement Agreement will not occur, and move the Council to dismiss this case in its entirety.

WHEREFORE, PacifiCorp and DEQ/AQD jointly request that the Council enter an Order dismissing the Council's limited jurisdiction over the Settlement Agreement.


