Dear Members of the Environmental Quality Council:

Previously Ms. Reece notified the EQC that they had failed to give any notice to Golden Predator Mines US Inc and she also included an exhibit, which I am enclosing again from her motion, which gives the legal description of their numerous claims within the area set forth to be declared rare and uncommon. I have been informed that Golden Predator Mines US Inc. is on the property to be considered as rare and uncommon with heavy equipment and numerous vehicles and is actively continuing to conduct operations with permits issued by the Forest Service. Apparently everyone knows that the EQC has failed to give them notice and they are the most material party that should be given notice before proceeding. It appears to me that EQC is intentionally avoiding giving notice to the party that will be most affected. Golden Predator Mines US is certainly entitled to notice before EQC proceeds with any hearing.

I realize that this is the fourth Sand Creek petition, drafted by Erik Molvar, a non-lawyer, and which is repeatedly filed and refiled, but if EQC has the duty to give notice then they should at least give notice to the mining company that is actively conducting mining operations on the property which the Sand Creek petitioners are seeking to have declared rare and uncommon. I would urge the EQC to give proper notice before proceeding with any hearing. I believe that to do otherwise would be a denial of due process.
