## RESPONSE OF THE DEPARTMENT OF ENVIRONMENTAL QUALITY

WHEREFORE, the DEQ/AQD respectfully requests that this Council uphold DEQ's issuance of Permit CT-4631 to Basin Electric Power Cooperative and deny Petitioners' requests for relief.
