**ORDER GRANTING STIPULATED MOTION FOR EXTENSION OF DEPOSITION  
AND DISPOSITIVE MOTIONS DEADLINES**

---

The Environmental Quality Council (EQC) having considered the parties' Stipulated Motion for Extension of Deposition and Dispositive Motions Deadlines finds and orders as follows:

1. As set forth in the Environmental Quality Council's (EQC) Scheduling Conference Order filed January 11, 2008, the deadline for discovery is August 1, 2008 and the deadline for dispositive motions is August 15, 2008 with responses due on September 4, 2008; and replies due on September 15, 2008.

2. The parties desire additional time in which to take expert depositions and file and brief dispositive motions, therefore,

IT IS ORDERED that the above deadlines be extended as follows:

- a. Deadline for expert depositions is extended to August 15, 2008;
- b. Deadline for dispositive motions is extended to August 29, 2008;
- c. Deadline for responses to dispositive motions is extended to September 12, 2008; and
- d. Deadline for replies to dispositive motions is extended to September 19, 2008.

IT IS FURTHER ORDERED that, due to a scheduling conflict, the parties proposed an extension of one or two days for the September 24, 2008 date for hearing oral arguments on dispositive motions, and it is therefore extended to September 29, 2008 at 1:00 PM in Room 217, Casper College, 125 College Dr., Casper, Wyoming.
