**STIPULATED MOTION FOR CONTINUANCE OF DISPOSITIVE MOTION  
BRIEFING DEADLINE**

Basin Electric Power Cooperative; the Department of Environmental Quality; and Protestants, Sierra Club, Wyoming Outdoor Council, and Powder River Basin Resource Council, by and through their respective counsel, respectfully move for an order extending the initial dispositive motion briefing deadline.

1. As set forth in the Environmental Quality Council's Order Granting Motion for Extension of Deposition and Dispositive Motion Deadlines, dated July 14, 2008, the deadline for dispositive motions is August 29, 2008; the deadline for responses to dispositive motions is September 12, 2008; and the deadline for replies to dispositive motions is September 19, 2008.

2. The parties desire additional time in which to file and brief dispositive motions, and propose extending only the initial dispositive motion deadline from August 29, 2008 to September 2, 2008.

3. The deadline proposed above does not impact any other date set forth in the EQC's Scheduling Conferencing Order filed January 11, 2008, in conjunction with Environmental Quality Council's Order Granting Motion for Extension of Deposition and Dispositive Motion Deadlines, dated July 14, 2008. The rest of the dispositive briefing schedule will remain the same.

Wherefore, the parties request that the initial dispositive motions deadline be extended to September 2, 2008, as jointly proposed above. A proposed Order is attached for the EQC's convenience.


