STIPULATED MOTION FOR EXTENSION OF PRELIMINARY OR PROCEDURAL MOTIONS AND RELATED DEADLINES AND MOTION FOR CONTINUANCE

Basin Electric Power Cooperative (Basin Electric); the Department of Environmental Quality; and Protestants, Sierra Club, Wyoming Outdoor Council, and Powder River Basin Resource Council, by and through their respective counsel, respectfully move for an order extending the preliminary or procedural motions deadline and related deadlines and for a continuance of the hearing on those motions. As grounds for this Motion, counsel state as follows:

- 1. As set forth in the Environmental Quality Council's (EQC) Scheduling Conference Order filed January 11, 2008, the deadline for preliminary or procedural motions is January 31, 2008; the deadline for responses to preliminary or procedural motions is February 20, 2008; and the deadline for replies to preliminary or procedural motions is March 6, 2008.
- 2. The parties desire additional time in which to file and brief preliminary or procedural motions and propose the following extensions:
- a. Deadline for preliminary or procedure motions be extended to February 8, 2008;

- b. Deadline for responses to preliminary or procedural motions be extended to March 12, 2008; and
- c. Deadline for replies to preliminary or procedural motions be extended to April 3, 2008.
- 3. The parties further move for a continuance of the hearing on preliminary or procedural motions. That motions hearing is set for April 7-8, 2008. The parties propose the hearing be continued to April 17-18, 2008.
