2. The Petitioner shall file their Expert Designations and Reports by August 10, 2009. The report shall state the credentials and opinions of each expert and contain a detailed summary of the facts and analysis that supports each opinion.
3. The Respondent and Third Party Respondent shall file their Expert Designations and Reports by August 27, 2009. The report shall state the credentials and opinions of each expert and contain a detailed summary of the facts and analysis that supports each opinion.
4. Depositions including depositions of Experts and written discovery of experts shall be concluded by September 11, 2009.
5. Any Dispositive Motions shall be filed by October 2, 2009.
6. Replies to Dispositive Motions shall be filed by October 12, 2009.
7. Hearing on any Dispositive Motions shall be heard on October 26, 2009, prior to the beginning of the hearing.
8. A pre-hearing conference on the matter shall be held on October 20, 2009, as scheduled by the Council.
9. Final hearing shall be held on October 26, 2009 through October 30, 2009, in Cheyenne, Wyoming.

10. All filings shall be made no later than 4:00 p.m. on the date set forth in this Order.


