- 3. Fact Discovery deadline is September 30, 2010.
- 4. Petitioner shall file Designation of Experts and Expert Reports by September 7th, 2010
- 5. DEQ and Permittee shall file Designation of Experts and Expert Reports by October 4th, 2010.
- 6. Dispositive Motions shall be filed by October 20th, 2010.

- 7. Responses to Motions due November 12th, 2010.
- Hearing on Dispositive Motions will be November 18th, 2010 at the University of Wyoming, Department of Engineering, 1000 East University Avenue, Room 1062, Laramie, WY.
- 9. Prehearing memorandums shall be filed by January 4th, 2011.
- 10. Prehearing Conference shall be held on January 7th, 2011. The conference shall be held at the offices of the Council in Cheyenne, Wyoming, 122 W. 25th St., Herschler Building, Room 1714, Cheyenne WY.
 - a. The purpose of the prehearing conference is:
 - i. Identification of witnesses, their addresses, phone numbers, and the substance of their proposed testimony;
 - ii. Clarification of the legal issues, both substantive and procedural, of all the parties, including identification of the statutory provisions and regulations that form the basis of the appeal;
 - iii. Stipulation to uncontested facts;
 - iv. Examination and marking of proposed exhibits and entering into stipulations to the foundation and admissibility of the exhibits and testimony; and
 - v. Pending motions.
- 11. Final Hearing on this appeal shall be heard on January 13th and/or 14th 2011. The

time and location shall be determined at a later date.

All documents shall be delivered no later than 4:00 on the above referenced dates unless

a different time is indicated for a specific paragraph. For the purpose of this order, deliver shall

mean that the recipient has the pertinent documents in hand. Delivery does not mean that the

original is mailed at the same time.

For the dispositive motion hearing and the prehearing conferences the parties may appear by telephonic means. Any party using this method must provide a direct line phone number to the Council seven days prior to the hearing or conference.

The parties shall have ten days from the date of receipt of this Order to file any objections to this Scheduling Order.
