<u>ORDER</u>

- 1. The Parties shall appear for a short pre-hearing conference in this matter that will he conducted on Tuesday, August 3, 2010 at 9:00 a.m. via telephone conference call. Failure to appear at the pre-hearing conference will result in dismissal from this case.
- 2. If the Parties have not filed a waiver on or before July 29, 2010 a court reporter will transcribe the hearing.

3. The DEQ shall assume the cost of the transcript and court reporter.
