**NOTICE OF VIOLATION AND ORDER**

**NOTICE IS HEREBY GIVEN THAT:**

1. Triple K Farms (Triple K) is the owner and operator of a Confined Animal Feeding Operation (CAFO) in Platte County, Wyoming which is permitted to discharge through the Wyoming Pollution Discharge Elimination System permit WY0043699.
2. Part I of the above referenced permit, under the Annual Reporting Requirements for CAFOs section, requires submittal of an annual report to the administrator by January 28 of each year. The Water Quality Division (WQD) sent a Letter of Violation (LOV) to Triple K on April 23<sup>rd</sup>, 2008 instructing them to send in the delinquent report to the WQD. The WQD did not receive a response to the LOV and did not receive the delinquent report.
3. This Notice is being sent to you pursuant to W.S. 35-11-701(c)(i), which requires that in any case of the failure to correct or remedy an alleged violation, the director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible;


**WHEREFORE IT IS HEREBY ORDERED THAT:**


1. Triple K shall immediately submit the complete and accurate delinquent report to the WQD. This information shall be received by the WQD no later than 30 days from the receipt date of this NOV and Order.
2. Within 30 days of the receipt date of this NOV and Order Mr. Taylor shall submit to the WQD a plan of action to ensure future reports are submitted in a timely manner.

This ORDER is final unless, no later than ten (10) days after the date this notice is received; it is appealed by filing two written requests for a hearing before the Environmental Quality Council. If a hearing is requested, the first hearing petition shall be mailed to the Chairman, Wyoming Environmental Quality Council, Room 1714 Herschler Building, 1<sup>st</sup> Floor West, 122 West 25<sup>th</sup> St., Cheyenne, Wyoming 82002. The second petition shall be mailed to the Director, Wyoming Department of the Environmental Quality, Herschler Building, 4<sup>th</sup> Floor West, 122 West 25<sup>th</sup> St., Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.

**NOTHING IN THIS NOTICE OF VIOLATION (NOV) AND ORDER** shall be interpreted to in any way limit or contravene any other remedy available under the Environmental Quality Act, nor shall this NOV AND ORDER be interpreted as being a condition precedent to any other enforcement action.
