Dear Sir and Madam:

Enclosed is a copy of the Notice of Violation and Order Docket Number 4659-10, issued to Trapper Trails Council, Boy Scouts of America and the National Forest Service for the construction of a public water system consisting of a water well, storage tanks, booster pumps and water mains without a permit to construct.

ANY APPEALS TO THE ENVIRONMENTAL QUALITY COUNCIL FROM THE ATTACHED ORDER MUST BE MADE IN WRITING WITHIN THE TEN (10) DAY LIMIT PRESCRIBED BY WYOMING STATUTE 35-11-701(c). Chapter 1, Section 3 of the Department of Environmental Quality Rules of Practice and Procedures sets forth the requirements for the initiation of appeal proceedings. You are urged to review all of the provisions of the attached Rules of Practice and Procedures as they relate to this action. To appeal this Order and request a hearing, you must file two (2) copies of your written petition. The first hearing petition shall be mailed to the Chairman, Wyoming Environmental Quality Council; 122 West 25<sup>th</sup> Street; Herschler Building, 1<sup>st</sup> Floor West, Room 1714; Cheyenne, Wyoming 82002. The second petition shall be mailed to the Director, Wyoming Department of Environmental Quality; 122 West 25<sup>th</sup> Street; Herschler Building, 4<sup>th</sup> Floor West, Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail return receipt requested.
