ORDER APPROVING STIPULATION TO
MODIFY ADMINISTRATIVE ORDER ON CONSENT

On November 17, 2010, Sweetwater County Solid Waste Disposal District #2 (District) and the Wyoming Department of Environmental Quality (DEQ) filed an Administrative Order on Consent (AOC) regarding permitting and operation of the District's Wamsutter landfill. The Wyoming Environmental Quality Council (EQC) entered an Order Approving Order on Consent dated January 13, 2011 (filed January 14, 2011), EQC Docket No. 10-5906. Subsequently, the District and the DEQ engaged in discussions resulting in agreement to modify the AOC as specified in their Stipulation to Modify Original Administrative Order on Consent (Stipulation), dated September 15, 2011, filed September 23, 2011.

W.S. 35-11-112(a)(ii) & (c) authorize the EQC to approve or modify DEQ orders. The EQC having considered the parties' Stipulation to Modify Original Administrative Order on Consent, and being advised in the matter,

IT IS HEREBY ORDERED that the parties' Stipulation to Modify Original Administrative Order on Consent is approved and the original AOC is now modified accordingly.


