NOTICE OF VIOLATION AND ORDER

NOTICE IS HEREBY GIVEN THAT:

1. **Pioneer Oil, LLC** obtained 5C5-3 General Permit coverage for five coal bed methane injection wells located in Sheridan County, Wyoming in 2001. A Letter of Violation (LOV) was issued August 27, 2010 for failure to submit quarterly monitoring reports for the following wells:

2. Pioneer Oil, LLC is in violation of Underground Injection Control General Permit 5C5-3, Parts IV(B)(1) and IV(B)(2) for failure to adhere to the monitoring and reporting requirements of the permit.
3. This Notice is being sent to you pursuant to W.S. 35-11-701(c)(i), which requires that in any case of the failure to correct or remedy an alleged violation, the director of the Department of Environmental Quality (DEQ) shall cause a written notice to be issued and served upon the person alleged to be responsible.


WHEREFORE IT IS HEREBY ORDERED THAT:

1. **Within 30 days** from the receipt of this Notice of Violation, Pioneer Oil, LLC will submit all delinquent reports for DEQ review and approval.
2. **Within 30 days** from the receipt of this Notice of Violation, Pioneer Oil, LLC will arrange for inspection of the facilities by DEQ personnel.


This ORDER is final unless, no later than ten (10) days after the date this notice is received; it is appealed by filing a written request for a hearing before the Environmental Quality Council. If a hearing is requested, the hearing petition shall be mailed to the Chairman, Wyoming Environmental Quality Council, Room 1714 Herschler Building, 1st Floor West, 122 West 25th St., Cheyenne, Wyoming 82002. The second petition shall be mailed to the Director, Wyoming Department of the Environmental Quality, Herschler Building, 4th Floor West, 122 West 25th St., Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.

NOTHING IN THIS NOTICE OF VIOLATION (NOV) AND ORDER shall be interpreted to in any way limit or contravene any other remedy available under the Environmental Quality Act, nor shall this NOV AND ORDER be interpreted as being a condition precedent to any other enforcement action.
