NOTICE OF VIOLATION  
AND  
ORDER

NOTICE IS HEREBY GIVEN THAT:

1. Jodie Newkirk owns the Arlington Outpost, storage tank facility number 0-000756, located at I-80 and Highway 13, McFadden, Wyoming. This site has three (3) regulated underground storage tanks.
2. Jodie Newkirk has not paid tank fees for the years 2010 and 2011 plus the associated late fees totaling eighteen hundred dollars and zero cents (\$1,800.00).
3. The DEQ has determined that Jodie Newkirk has violated W.S. § 35-11-1425 of the Wyoming Environmental Quality Act.
  - (a) On or before January 1 of each year the owner of a tank shall pay a fee to the department of two hundred dollars (\$200.00) per tank owned....
4. This Notice is being sent to Jodie Newkirk pursuant to W.S. 35-11-701(c)(i), which requires that in any case of the failure to correct or remedy an alleged violation, the director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible.

ORDER

BEFORE THE ENVIRONMENTAL QUALITY COUNCIL-STATE OF WYOMING

WHEREFORE IT IS HEREBY ORDERED THAT:


1. Jodie Newkirk pay the tank and associated late fees within thirty (30) days of receipt of this Notice of Violation.

THIS ORDER is final unless, not later than ten (10) days after the date this notice is received, it is appealed by filing a written petition for a hearing before the Environmental Quality Council. If a hearing is requested, the petition shall be mailed to the Chairman, Wyoming Environmental Quality Council, Room 1714 Herschler Building, 1st Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. The second petition shall be mailed to the Director, Wyoming Department of Environmental Quality, Herschler Building, 4th Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.

NOTHING IN THIS ORDER shall be interpreted to in any way limit or contravene any other remedy available under the Environmental Quality Act, nor shall this Order be interpreted as being a condition precedent to any other enforcement action.
