**ORDER MODIFYING ADMINISTRATIVE ORDER ON CONSENT**

On March 1, 2011, the Wyoming Department of Environmental Quality, Solid and Hazardous Waste Division, and the City of Rawlins entered into an Administrative Order on Consent for the purpose of bringing the City's municipal solid waste management facility operations into compliance with the permit requirements of Wyo. Stat. § 35-11-502 and the Solid Waste Rules and Regulations. The parties have since jointly stipulated to modify the terms of the Administrative Order on Consent, and requested on December 20, 2011, that the Council approve the modifications. Having considered the matter in accordance with Wyo. Stat. § 35-11-112(a)(ii), and being fully advised in the premises;

IT IS HEREBY ORDERED THAT the Administrative Order on Consent be modified in accordance with the terms stipulated to by the parties.


