JOINT STIPULATION REGARDING DISBURSEMENT OF
CASH APPEAL BOND

COME NOW Landrica Development Company (“Landrica”) and the Department of environmental Quality, Land Quality Division (“DEQ/LQD”) by and through their respective undersigned counsel, and hereby stipulate as follows:

1. The Joint Stipulation Dismissing Appeal to the Environmental Quality Council provides that the penalty is reduced from \$25,000.00 to \$15,000.00 as provided by Paragraph 4, Decision of the “Director” Findings of Fact, Conclusions of Law and Decision” In the matter of a Notice of Violation Issued to Landrica Development Company, KFX Mine P.O. Box 1777, Gillette, WY 82717-1777 Permit No. 486-T5, Nov No. 100516, Docket NO. 3928-06 (hereinafter “Director’s Findings”).
2. Landrica has previously posted a cash appeal bond in the amount of \$25,000.00 with the Environmental Quality Council.

Therefore, in consideration of the foregoing, Landrica and DEQ/LQD stipulate and agree that the \$25,000.00 cash bond shall be disbursed as follows:

\$15,000.00 to DEQ/LQD

\$10,000.00 to Landrica


