## PUBLIC NOTICE

Croell Redi-Mix, Inc. of Sundance, Wyoming has applied for a small mining permit from the Land Quality Division of the Department of Environmental Quality for the State of Wyoming. The mining permit area for the mining of gravel will be located in: NE1/4NE1/4 and E1/2SE1/4NE1/4 of Section 25, Township 24 North, Range 69 West, Platte County, Wyoming. The McGuire Pit is Tocated approximately 5.25 miles southwest of Wheatland, Wyoming, southwest of the junction of Washington Road and Sybille Creek Road, The proposed operation is scheduled to begin January 2011 and is estimated to continue until 2033. The land, after mining will be returned to a grazingland. Information regarding the proposed mining operation and reclamation procedures may be reviewed in the Office of the Land Quality Division of the Department of Environmental Quality in Cheyenne, Wyoming, the office of Croell Redi-Mix, Inc. in Sundance, Wyoming or the Platte

County Clerk's Office Wheatland, Wyoming. Upon request by an interested party, the Land Quality Division may schedule a public meeting to discuss the application. If such a meeting is scheduled, it must be prior to the date for the close of public comments. If concerns about the permit are not resolved by the Land Quality Division, written objections to the proposed mining operation must be received by the Administrator of the Land Quality Division of the Department of Environmental Quality, Herschler Building, 122 West 25th Street, Chevenne, WY 82002 before the close of business January 7, 2011. If an objection is submitted, a public hearing shall be held within twenty (20) days after the final date for filing objections unless a different period is stipulated to by the parties. The Council or Director shall publish notice of the time, date and location of the hearing or conference in a newspaper of general circulation in the locality of the proposed operation once a week for two (2) consecutive weeks immediately prior to the hearing or conference. The hearing shall be conducted as a contested case in accordance with the Wyoming Administrative Procedure Act (W.S. §16-3-101 through §16-3-115, and the right of judicial review shall be afforded as provided in that act. All parties as given in W.S. §35-11-406(j) will be mailed a copy of this notice. The Wyoming Oil and Gas Conservation Commission will be mailed a copy of the application mine plan map as required in W.S. §35-11-406(i).
