PRE-HEARING MEMORANDUM

Comes now, Mary A. Throne of Throne Law Office, P.C., on behalf of Owl Creek Gravel Products, LLC (Owl Creek) to submit this Pre-Hearing Memorandum, pursuant to the May 4, 2011 Order of the Environmental Quality Council.

LEGAL ISSUES

Whether the Objectors, Matt and Theresa Brown, have demonstrated the proposed small mine permit fails to meet the requirements of Article 4 of the Wyoming Environmental Quality Act.

Whether the Council has jurisdiction over the case under Wyo. Stat. § 35-11-406(k) since Matt and Theresa Brown did not provide their objections to the parties until the prehearing conference held on May 3, 2011.

SUMMARY OF THE CASE

Owl Creek applied for a small mine permit under Wyo. Stat. § 35-11-401(j) for the construction of a gravel mine in Hot Springs, County on October 28, 2010. The proposed permit went to public notice on March 24, 2011, with a deadline for objections of April 23, 2001. Matt and Theresa Brown filed their intention to object on April 18, 2011, but failed to state any specific objections by April 23, 2011. Based on oral representations of the Browns' counsel at the prehearing, Owl Creek understands the objections are limited to concerns about whether the proposed permit protects downstream water interests. To date, Mr. and Mrs. Brown have never provided their specific objections in writing which has hampered Owl Creek's ability to prepare for the hearing. As a result, Owl Creek may seek leave to supplement Witness and Exhibit lists.

The mine plan and the reclamation plan for the proposed gravel operation contain several requirements intended to protect groundwater interests. In August 2010, representatives of Owl Creek met with Loren Smith, the Superintendent for Water Division III for the Wyoming State Engineer, to discuss stipulations for the operation that he would like to see to protect the aquifer. Mr. Smith requested that two feet of gravel remain on the floor of the pit during operations and following reclamation to allow water

to flow through the property to down gradient users. The mine plan contains this stipulation. In addition, during operation, a drain ditch will be in place to convey stormwater and any water in the pit to an existing drain ditch that borders the property, allowing water to flow down gradient. During mining and following reclamation there will be no impoundments on the property that could affect downstream users.

With these mine plan and reclamation plan requirements in place, the proposed permit addresses the concerns voiced in 2010 by Mr. Smith and will prevent injury to downstream holders of water rights. However, in the event there is any injury to water rights resulting from the operation, the mine plan requires the permittee "to make all reasonable efforts to remedy said injury."

Loren:

Thank you for your prompt consideration and review of our request for guidance on acceptable mining plans for this pit. We fully understand and share your desire to protect the appropriators on Steward Springs and Lower Owl Creek by assuring continued groundwater migration through (or around) the site area after operations cease and reclamation is complete. We will proceed with preparation of the mine permit application with the understanding that for now we will leave at least two feet of gravel above the pit floor wherever the pit encroaches on the seasonal high water table. If, through additional planning, data collection and analysis, we can demonstrate to your satisfaction that leaving two feet of gravel is not necessary or helpful to assure protection of downstream appropriators, we may request permission to modify this constraint. After all, 2 feet of gravel over 60 acres is about 200,000 cubic yards, or over 300,000 tons of material.

Harry,

Dave Deutz, my assistant superintendent and I toured the site of the proposed expansion late last week and we have discussed this with Tiffany Searcy the hydrographer for district 5, we have arrived at the conclusion that at mining can proceed to such a depth as to leave two feet of the gravel remaining above the Cody Shale interface. The primary reasoning behind this requirement is that we must protect the appropriators on Steward Springs and Lower Owl Creek and their source of supply by maintaining enough of this aquifer to assure continued groundwater migration through the site area after operations have ceased and reclamation is completed. Thank you for the opportunity to look into this early in the process.
