

**JOINT STIPULATED MOTION TO MODIFY PREHEARING DEADLINES**

1. On July 7, 2011, the Presiding Officer entered an Order setting Monday, July 18, 2011 as the deadline for Parties to exchange witness and exhibit lists.
2. The Parties met on Friday, July 15, for the purpose of discussing the possible resolution or narrowing of the various issues presented in Petitioner's Amended Written Objections relating to sage grouse core habitat conservation. As part of those efforts, and due to the substantial size and scope of the Application for Permit to Mine, the Parties are further coordinating in an effort to identify those volumes or sections of the Application that are most relevant to the issues presented by Petitioner and which Petitioner may hereafter designate for use as exhibits during the hearing.
3. The Parties have agreed and respectfully request that the deadline for the designation and exchange of witness and exhibit lists be modified as follows:
  - a. Wednesday, July 20, 2011, for the designation of all witnesses, and for the designation of all exhibits other than specific volumes or sections of the Application.
  - b. Monday, July 25, 2011, for the designation of specific volumes or sections of the Application that may be presented as exhibits in this matter.
4. This Stipulated Motion is not intended to and shall not affect any other deadlines set forth in the Order or that may otherwise apply to these proceedings pursuant to the Council's Rules of Practice and Procedure.
