

AFFIDAVIT OF PUBLICATION

Public Notice

Croell Redi-Mix, Inc. of Sundance, Wyoming has applied for a mining permit from the Land Quality Division of the Department of Environmental Quality for the State of Wyoming. The mining permit area will be located in: S1/2SW1/4 of Section 15, the N1/2NE1/4, SE1/4NE1/4, and the NE1/4SE1/4 of Section 21, and the W1/2NW1/4 of Section 22 in Township 52 North, Range 83 West, 6PM, Johnson County, Wyoming. The Shell Creek Pit is located approximately ten miles northwest of Buffalo, Wyoming, approximately two miles west of Interstater 90 and 3.5 miles west of Lake De Smet. The proposed operation is scheduled to begin June 2012 and is estimated to continue until 2023. The land, after mining will be returned to a grazing land.

Information regarding the proposed mining operation and reclamation procedures may be reviewed in the Office of the Land Quality Division of the Department of Environmental Quality in Cheyenne and Sheridan, Wyoming, the office of Croell Redi-Mix, Inc. in Sundance, Wyoming or the Johnson County Clerk's Office Buffalo, Wyoming.

Written objections to the proposed mining operation must be received by the Administrator of the Land Quality Division of the Department of Environmental Quality, Herschler Building, 122 West 25th Street, Cheyenne, WY 82002 before the close of business June 11, 2012. If an objection is submitted, a public hearing shall be held within twenty (20) days after the final date for filing objections unless a different period is stipulated to by the parties. The Council or Director shall publish notice of the time, date and location of the hearing or conference in a newspaper of general circulation in the locality of the proposed operation once a week for two (2) consecutive weeks immediately prior to the hearing or conference. The hearing shall be conducted as a contested case in accordance with the Wyoming Administrative Procedure Act (W.S. §16-3-101 through §16-3-115, and the right of judicial review shall be afforded as provided in that act. All parties as given in W.S. §35-11-406(j) will be mailed a copy of this notice. The Wyoming Oil and Gas Conservation Commission will be mailed a copy of the application mine plan map as required in W.S. §35-11-406(j).
