## STIPULATED AGREEMENT FOR FINAL HEARING

On June 22, 2012, the following parties or their representatives appeared either in person or by phone pursuant to a Notice of Hearing and Order for a prehearing conference. Luke Esch, Assistant Attorney General, for the Department of Environmental Quality; Jake Brooks, Lonabaugh & Riggs, LLP, on behalf of Mr. and Mrs. Troy Ehrmantraut; Mark Stewart, Davis & Cannon, LLP, and Julie Ewing on behalf of Croell RediMix Inc.; Jacob Gay and Fred Matthews. Failing to appear pursuant to the Notice of Hearing and Order were Kim Love, Steve Wuthier, Dan Gay, Jerry Ruby, Larry Brannian and Chuck Evitt.
