**ORDER OF DISMISSAL**


On January 23, 2013 the Department of Environmental Quality, Land Quality Division filed with the EQC a document prepared and filed with the Department by Jason A. Lillegraven, entitled RE: Comments on application for amendment to Arch of Wyoming Saddleback Hills underground coal mining Permit 730-T2. On January 23, 2013 the Council received a forwarded email from Mr. Lillegraven that stated "I do not personally intend to pursue legal issues raised within my letter of January 18, 2013." On January 25, 2013 the department filed with the Council a document containing comments regarding the Arch of Wyoming Saddleback Hills underground coal mining Permit 730-T2 from Reese and Willing John Johnson. The last line of the document stated "Thank you for considering these comments." On January 29, 2013 Mr. and Mrs. Johnson via emailed stated "We do not wish to purse a hearing with EQC....". Based upon the filings by the Department the Council opened the above entitled docketed matter. Based upon the filings by Mr. Lillegraven and Mr. and Mrs. Johnson the matter is hereby dismissed.


