BOULDER RESIDENT OBJECTORS' LIST OF WITNESSES AND EXHIBITS AND STATEMENT OF ISSUES

Objectors Dave and Sandra Goodwin, Harv and Denise Hastings, Debbra White, David Payne, Randy Simpson, and Kelly Garside (collectively the "Boulder Residents") respectfully submit this list of witnesses and exhibits and statement of issues, as required by the Order of Schedule entered in this matter on May 24, 2013 by 5 p.m.

I. List of Witnesses

Each of the objectors set forth below intend to testify at the hearing, work and weather permitting. Each is a resident of Boulder, Wyoming and owns property very near the proposed mine. Each will testify regarding the location of their property in proximity to the mine and their experience with the mine and its related truck traffic. They will recount the noise, dust, and public safety problems caused by the truck traffic and the operation of the mine itself, and the effect the mine's operation has had on their use of public roadways and public lands in the area. They will also share their observations of sage grouse activity in the area, and the impact that mine operation has had on the number of such birds frequenting the area. David Goodwin, Objector

In addition to the topics indicated above, Dave Goodwin may testify about damage to his home, wildlife in the Boulder area, and how McMurry mining operations caused him stress and anxiety. He may be asked to testify concerning photographs he took of cropland. He may also be asked to testify concerning photographs he took of Highway 353, photographs he took of trucks exiting and entering the McMurry mine, and safety concerns with the McMurry mine entrance.

Sandra Goodwin, Objector

In addition to the topics indicated above, Sandra Goodwin may be called to testify concerning wildlife in the Boulder area, damage to her home, and how previous McMurry mining operations caused her stress, anxiety, sleeplessness, migraines, and clinical depression. She may be asked to testify about safety concerns with the McMurry mine access.

Denise Hastings, Objector

Denise Hastings will not be present at the hearing. However, a transcript of her testimony from the previous EQC hearing is listed as Exhibit 29, and the Objectors' will move to have the exhibit admitted at the upcoming hearing. This testimony includes how she and her husband, Harv Hastings, used Highway 353 prior to operations of McMurry's mine operation in the Boulder Area. Testimony will include how the McMurry mine operation disrupted the public peace.

In addition to the topics indicated above, Debbra White may be called to testify concerning her property in the area and the stress that McMurry mine has caused her.

In addition to the topics indicated above, David Payne may be called to testify about how the McMurry mine has deterred him from building a home in the Boulder area, and the stress this has caused him.

Randy Simpson, Objector

In addition to the topics listed above, Randy Simpson may be called to testify concerning his and his wife's use of the road prior to McMurry's mining operation. He may also testify about road safety concerns, stress, headaches, sinus problems, and hearing issues.

7. Kelly Garside, Objector 1491 Highway 353 Boulder, WY 82923

In addition to the topics listed above, Kelly Garside may testify about wildlife in the Boulder area, damage to his home, and increased sinus infections during McMurry mining operations. He may be asked to testify about photographs he took of the mine and the mine entrance. He may also be asked to testify concerning safety issues with the McMurry access.

Several of the objectors may be unable to travel to Cheyenne for the hearing due to health concerns and work conflicts. Their testimony may be presented by telephone, or in the form of their prior sworn testimony before the Council.

Mary Flanderka may be called to testify about Executive Order 2011-05, Sage Grouse, and the Density Disturbance Calculation Tool (DDCT). She may be asked to testify about guidance the Wyoming Game and Fish Department gave to Steve Stresky in conducting the DDCT. She may be asked to testify about correspondences with McMurry and Steve Stresky. She may be asked to testify about croplands, suitable sage grouse habitat, unsuitable sage grouse habitat, and disturbed areas. She may also be called to testify about the overall DDCT disturbance analysis and individual lek disturbance analysis. She may also be asked to testify about Wyoming Game and Fish Department's approval of McMurry's DDCT.

10. Darrell SnyderWyoming Department of TransportationMaintenance Foreman, Pinedale Office

Darrell Snyder may be called to testify by telephone concerning the McMurry mine entrance. He may testify about his correspondence with McMurry, the work he performed concerning the McMurry mine entrance, and the letter he sent to McMurry designating the McMurry entrance a commercial access.

Steve Stresky may be called to testify concerning the McMurry mine application permit.

The Boulder Residents furthermore reserve the right to use and introduce any exhibit listed by any other party, and to use any other documents or things that may be necessary for the purposes of impeachment on cross-examination, or as rebuttal evidence.

III. Statement of Issues

The issue presented to the EQC for adjudication in this contested case hearing is whether a permit may be issued to McMurry Ready Mix Co. under Wyo. Stat. § 35-11-406 for the operation of a 350 acre gravel mine when the operation of that mine endangers public health and safety, constitutes a public nuisance, and does not comply with Executive Order 2011-05.

a. The Proposed Mine Endangers Public Health and Safety

The issue is whether the McMurry mine permit application continues to endanger the health and safety of the Boulder Residents and members of the public in violation of Wyo. Stat. § 35-11-406 (m)(vii) when trucks must still cross over the centerline into oncoming traffic when entering and exiting the McMurry mine.

b. Proposed Mine is a Public Nuisance

The issue is whether the McMurry mine permit application continues to be a public nuisance in violation of Wyo. Stat. §35-11-406 (m)(vii) when the permit does not limit the frequency of trucks, hauling activity, or overall disturbance of the peace.

c. The McMurry DDCT is not in Compliance with Executive Order 2011-05

The issues is whether the McMurry mine permit application is in compliance with Executive Order 2011-05 and not contrary to the policy of Wyoming under Wyo. Stat. 406(m)(iii).
