- 7. May 20, 2013: Deadline for DEQ and McMurry to designate their respective expert witnesses. Such designation(s) shall consist of either a written report prepared and signed by the witness or disclosure signed by the attorneys for these parties. The designation must otherwise comply with the requirements of Wyo.R.Civ.P. 26(a)(2).
- 8. May 24, 2013: Deadline for exchanging Witness List, Exhibits, and Statement of Issues and Final Hearing Briefs by 5:00 p.m.
- 9. May 28, 2013: Deadline for completing discovery.
- 10. May 30 and 31: Final Hearing before the EQC to begin at 9:00 a.m.Such hearing will be held at Cheyenne WY.

electronic means. The parties may file all of the foregoing documents with the EQC by electronic means.
