Dear Administrator of the Land Quality Division:

I currently own land located one mile from the proposed Sugarland Partners, LLC marble mining permit site (Permit 292C) located in Platte County, Wyoming in Section 3, T24N, R70. I would like to inform you that current landowner names on land surrounding the proposed mine are incorrect.

Luke Corl has not owned land next to the mine for some twelve years. Many other inaccurate assumptions are in this permit request.

For example, I object to the permit allowing the mine owners to reclaim the site with sunflowers. Sunflowers are native to the southeastern part of the United States, not to Wyoming. Sunflowers have never been used to reclaim any Wyoming highway right of way sections because they do not prevent soil from blowing away. The idea of any reclamation effort is to prevent land erosion. Reclamation efforts in Platte County need to have grasses native to this area planted to ensure a tight hold on the land to prevent a dust bowl situation from developing. A sunflower has a long stem and nothing around the bottom of the plant to prevent land erosion. It is top heavy, creating an ideal plant to be lifted up and blown away by the ferocious winds we have in this area of Platte County. These dried up sunflowers would end up on eastern border fences of the area, pushing down those fences.

The bond of \$15,000 that the reclamation department is requesting is too little. I drove by the mine site frequently when it was previously reclaimed. Many bulldozers worked 24 hours round the clock for six months to finish the reclamation effort. \$15,000 would not pay for even one of those workers. That reclamation effort was supposed to include brush and tree plantings which were never done. Sharon Utter and Larry Wilson complained to me about the tin etc. used in the old mine buildings just being pushed in to the big hole and covered up with dirt. The reclamation effort at that time produced dust bowls whenever the wind blew until enough grass covered the reclaimed land to keep dust bowls from forming. If sunflowers are planted, there is no hope of any dirt staying on the ground during the winter months, which in Wyoming, would be 8 months.

The Wyoming office of the Land Quality division needs to make sure that a proposed mine will minimize impacts to the environment and that areas would be properly restored after this mining area is closed. Permit 292C does not properly address environmental impacts to the site and should be denied. Thank you for your attention to this matter.
