As of today:

- 1. Linc has submitted today (June 13, 2013) the responses for the latest review round (seventh round responses). The aquifer exemption review responses (third round responses) were received on June 7, 2013.
- The LQD will need to provide a response within 30 days, so we are looking at July 13, 2013. I am checking with Mark and Chris Lidstone to see if we can expedite the review.
- 3. There were three outstanding comments at the end of last review round. With the clarification that the LQD/Lidstone provided with a cursory review on June 6, 2013 and during the meeting in Cheyenne on June 4, 2013, I am expecting this will be the last review round from LQD.
- 4. WQD will need to review the aquifer exemption SOB before forwarding it to EPA. The LQD will declare the application complete after the approval from WQD. I am expecting the LQD will be forwarding the SOB to WQD in the next two weeks.
- 5. Based on the meeting with Linc on June 4, 2013, Jeremiah Williamson is working on a format for the State Decision Document that considers the fact that this is a R&D license application.
