ORDER

A short pre-hearing conference will be held in this matter to discuss time frame for discovery, possible hearing dates and time needed for the Parties to present their case. The conference will be conducted on Monday October 28th, 2013 at 8:15 a.m. via telephone conference call. The Parties should provide the EQC office with a direct telephone number and an email address where they can be reached for the pre-hearing on or before noon October 25th, 2013 . Failure to appear at the pre-hearing conference may result in dismissal from this case.

In accordance with the DEQ Rules of Practice and Procedure, Chapter 1, Section 6, "Unless otherwise agreed to by the parties and consented to by the Council, all hearings, including all testimony, shall be reported verbatim by a competent reporter. The compensation of such reporter shall be paid as required by law and as ordered by the Council. The Council may direct any party or parties to assume the cost of the transcript." If the Parties do not file a waiver to this section, the Parties should equally pay the costs of the transcript.

IT IS HEREBY ORDERED



Failure to appear at the pre-hearing conference will result in dismissal from this case.
2. If the Parties have not filed a waiver on or before October 25th, 2013 a court reporter will transcribe the hearing.
3. Each party shall assume a share of the cost of the transcript and court reporter.
