Unique and Irreplaceable Designation Resolution No. I January 25, 1974 OCT 2 4 2007

The initial designation of restricted areas in Wyoming shall include but shall not be limited to those places which are now or hereafter included in the Wyoming Recreation Commission Inventory of Historical Places, the U.S. Department of Interior National Register of Historical Places, national and state parks, national and state wildlife refuges, National System of Trails, the National Wilderness Preservation System, The Wild and Scenic Rivers System, National and State Recreation areas, monuments, forts, museums, ranger stations, petroglyph sites, dams, depots and any area which may adversely affect a publicly owned park, or sites and places listed by the University of Wyoming Department of Archaeology, the Wyoming Recreation Commission, and the Wyoming Archives and Historical Department.

This designation shall also include sites and places identified by mining permit applicants within the proposed development area as having more than local interest and importance as a restricted area.

Unique and Irreplaceable Designation Resolution No. II October 25, 1974

- a. All of Section 14; NE1/4 NE1/4 Section 15; All of Sections 1, 2, 3, 10, 11, 12, and 13, in T53N, R84W; and all of Sections 5, 6, 7, 8, 14, 15, 16, 17 and 18 in T53N, R83W of Sheridan County for a total of approximately 10,920 acres, and;
- b. The E1/2 Section 23; NE1/4 Section 26; all of Sections 24 and 25 in T53N, R84W; and all of Sections 19, 20, 21, 22, 23, 26, 27, 28, 29 and 30 in T53N, R83W of Johnson County for a total of approximately 8,160 acres.

Unique and Irreplaceable Designation Resolution No. III October 25, 1974

The S1/2 NE1/4, E1/2 SW1/4, SE1/4 Section 23; NE1/4, NE1/4 NW1/4, N1/2 SE1/4, SE1/4 SE1/4, Section 26 in T52N, R84W; and NE1/4, E1/2 NW1/4, NE1/4 SE ½ Section 12 in T51N, R84W of Johnson County for a total of approximately 920 acres.

Rare or Uncommon Designation of Jackson Canon, Gothberg Draw and Little Red Creek, and Eagle Roost August 8, 1978

Sections 7, 16, 17, 18, 20, 21, 22, 23, 25, 26 and 27, T32N, R80W, and Sections 12 and 13, T32N, R81W in Natrona County, commonly known as Jackson Canyon, Little Red Creek, Gothhberg Draw, and Eagle Roost.

Rare or Uncommon Designation of Bessemer Mountain July 1994

Sections 8, 9, 10, 15, 16, 17, 20, 21, and 22 of T32N, R81W, 6th PM, Natrona County.

Rare or Uncommon Designation of a Portion of Section 36, T29N, R87W November 25, 2002

That area of Section 36 lying north and west of the Highway 220 easement as very rare or uncommon and as having particular historical value. The legal description for the Highway 220 easement is as follows:

All that portion of the SW½: NW½SE½: SE½NW½: NE½ of Section 36, T. 29 N., R. 87 W. of the 6th P. M., Wyoming, lying between parallel right of way lines 300 feet apart, being 150 feet on each side when measured at right angles or radically to the following described survey line of highway, said parallel right of way lines extending to and terminating at the legal boundaries of said Section 36: Beginning at a point on the west boundary of said Section 36 from which the Southwest corner thereof bears S 0° 02.5' E. a distance of 830.6 feet; thence N. 71° 32' E. a distance of 264.6 feet to the point of beginning of a 1° 00' circular curve to the left, the radius of which is 5,729.6 feet; thence along said curve through a central angle of 38° 50' a distance of 3,883.3 feet to the point of ending of said curve; thence N. 32° 42' E. a distance of 2,369.8 feet, more or less, to a point on the north boundary of said Section 36 from which the northeast corner thereof bears N. 89° 11.5' E. a distance of 723.1 feet.
