## MOTION FOR CONTEMPT AGAINST ERIK MOLVAR AND REQUEST FOR STAY OF PROCEEDINGS

COMES NOW, John Green, General Partner of Mineral Hill, L.P., which are surface and mineral owners of property located in the Sand Creek area and motions that Erik Molvar be held in contempt and the proceedings stayed until further order of the EQC based upon the following grounds and reasons.

The above referenced petition filed on behalf of the Friends of Sand Creek, Prairie Hills Audubon Society, Defenders of the Black Hills and the Biodiversity Conservation Alliance, was filed unsigned. However, the Addendum filed on 06/01/2009 is signed by Erik Molvar.

According to the records of the Wyoming State Bar, Erik Molvar is not a licensed attorney. The website for the Biodiversity Conservation Alliance (<a href="www.voiceforthewild.org">www.voiceforthewild.org</a>), advertises Erik Molvar as a biologist who authors appeals and legal briefs. See Exhibit A.

Wy. Stat. Ann. 33-5-115 provides for a stay of proceedings as follows:

"The court may, on motion of either party, and on the showing of reasonable grounds therefor, require the attorney for the adverse party, or for any one (1) of several adverse parties, to produce or prove, by his own oath or otherwise, the authority under which he appears, and until he does so, may stay all proceedings by him, on behalf of the parties for whom he assumes to appear."

Wy. Stat. Ann. 33-5-117, with regard to the unauthorized practice of law, provides:

"It shall be unlawful, and punishable as contempt of court, for any person not a member of the Wyoming state bar to hold himself out or advertise by whatsoever means as an attorney or counselor-at-law." Wherefore, it is respectfully requested that all proceedings in the above cause be stayed until such time as Erik Molvar produce or prove his authority to practice law in the State of Wyoming and upon failure to do so, that he be held in contempt of court.
