
Dear Mr. Oja:

Enclosed you will find a Notice of Violation and Order, Docket Number 4194-07, issued under the provisions of W.S. 35-11-701(c). Letters have been sent by the department to you on numerous occasions informing you about the requirements for temporarily out of use underground storage tanks. Those requirements include the requirement to maintain, inspect, and service sacrificial anode systems. Since this tank was placed in temporarily out of use condition in 1998, there has never been a test of the sacrificial anode system. You have failed to have the system tested every three years.


Please be aware that the attached Notice of Violation contains an Order detailing what must be done to eliminate and rectify the violation.

ANY APPEALS TO THE ENVIRONMENTAL QUALITY COUNCIL FROM THE ATTACHED ORDER MUST BE MADE IN WRITING WITHIN THE TEN (10) DAY TIME LIMIT PRESCRIBED BY W.S. 35-11-701(c). Chapter I, Section 3 of the enclosed Department of Environmental Quality Rules of Practice and Procedure sets forth the requirements for the initiation of appeal proceedings. You are urged to review all of the provisions of the attached Rules of Practice and Procedures as they relate to this action.

If you appeal this order and request a hearing, please file two (2) copies of your written petition. One copy of the petition should go to the Chairman of the Environmental Quality Council at Room 1714, Herschler Building, 1st Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. The second petition should be sent to John V. Corra, Director, Wyoming Department of Environmental Quality, Herschler Building, 4th West, 122 West 25th Street, Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.
