

**WITHDRAWAL OF PETITION FOR LEAVE TO INTERVENE AND  
REVIEW OF DEQ'S NOTICE OF COMPLIANCE  
FOR ADMINISTRATIVE ORDER #4316-08**

Frontier Refining Inc. (Frontier) hereby files this Withdrawal of its previous Petition for Leave to Intervene in this proceeding. After filing its Petition for Leave to Intervene on August 14, 2008, Frontier has determined that it does not wish to pursue the matter of The Review of the Administrative Order Issued to Arp & Hammond Hardware Co. and/or Old Horse Pasture, Inc. (OHP) by the Department of Environmental Quality (DEQ) on July 21, 2008 which required OHP to grant Frontier and its contractors access to OHP property adjacent to the Frontier Refinery as needed for installation of a barrier wall boundary control system. As such, Frontier respectfully requests that its Petition for Leave to Intervene and Review of DEQ's Notice of Compliance for Administrative Order #4316-08 be withdrawn and that no further action be taken regarding Frontier's pleading filed in this matter on August 14, 2008.
