- 1. The Parties shall appear for a short pre-hearing conference in this matter that will he conducted on Wednesday, January 21, 2009 at 3:00 p.m. via telephone conference call. Failure to appear at the pre-hearing conference will result in dismissal from this case.
- If the Parties have not filed a waiver on or before January 16, 2009 a court reporter will transcribe the hearing.
