Respondent Wyoming Department of Environmental Quality (DEQ), pursuant to the Wyoming Environmental Quality Council's (EQC) Response Order dated and filed September 19, 2008, responds as follows to Petitioner Fremont County Solid Waste Disposal District's (FCSWDD) Petition for Review of Notice of Violation and Request for Hearing (Petition) dated September 16, 2008, filed September 18, 2008:

1.a. Admit that the permitting process has been delayed, but deny the remainder of averment 1.a.

1.b. Admit that DEQ issued a temporary, conditional permit extension to FCSWDD with an expiration date of March 15, 2008, and that FCSWDD did not protest it.

1.c. Admit that the HGI Report was delivered to DEQ on August 27, 2008, but deny that the report contains recommendations for either number or location groundwater monitoring wells for review by DEQ, and deny the remainder of averment 1.c.

1.d. Deny that WYO. STAT. ANN. § 35-11-502(a)(ii) does not prohibit extension of the use of Phase 4 and expansion into Phase 5 for construction and demolition waste only without authorization under the permit system, and deny that extension of the use of Phase 4 and expansion into Phase 5 for construction and demolition waste only are currently authorized.

1.e. Admit that DEQ requires submittal of complete permit applications for review. Deny FCSWDD has submitted a complete permit application or that the "full plan" is "awaiting the receipt, review and direction of the water quality analysis and monitor wells by the [DEQ]."
