STIPULATION TO MODIFIY ORIGINAL JOINT STIPULATION

On March 20, 2009, Petitioner Fremont County Solid Waste Disposal District (SWDD) and Respondent Wyoming Department of Environmental Quality (DEQ), Solid & Hazardous Waste Division filed a Joint Stipulation for <u>Disposition and Dismissal of Appeal</u> in the above-captioned case before the Wyoming Environmental Quality Council (EQC). Fremont County SWDD and DEQ are the only parties in this case. Chapter 1, Section 11 of the DEQ Rules of Practice & Procedure provides for the disposition of contested cases by stipulation of the parties upon approval of the EQC. The EQC entered an <u>Order Approving</u> Joint Stipulation and Dismissing Appeal on March 26, 2009 (filed March 27, 2009).

As a result of subsequent discussions regarding implementation of the terms of the original March 20, 2009 Joint Stipulation, Fremont County SWDD and DEQ now stipulate and agree that the original Joint Stipulation should be modified only as follows:

1.E. Submittal of a complete renewal permit application for the Lander landfill, including but not limited to the information identified in work item E in DEQ Order No. 4351-08, within the timeframe specified for item E in the January 30, 2009 letter from IME to James Hedges not later than May 1, 2011 will satisfy item E in DEQ Order No. 4351-08, with the following stipulated modification to clarify that a complete renewal permit application also includes the following submittals:

All other terms of the original Joint Stipulation not specifically modified above remain unchanged and in effect as originally approved by the EQC.
