## WYOMING DEPARMENT OF ENVIRONMENTAL QUALITY'S RESPONSE TO SUBLETTE COUNTY'S PETITION

Wyoming Department of Environmental Quality (DEQ), pursuant to the Wyoming Environmental Quality Council's (EQC) March 24, 2009 Response Order hereby responds as follows to the allegations of fact in Sublette County's Petition for Review and Request for Hearing (Petition) in the above-captioned matter.

- 3.a) DEQ admits the averments in ¶3.a. of the Petition.
- 3.b) DEQ admits that the January 14, 200[9] letter from the Administrator of the DEQ Sold & Hazardous Waste Division (SHWD) to the Sublette County Commissioners contains a final determination that "all future disposal area/s at the Marbleton #2 Landfill must be constructed with an approved ECS" (Engineered Containment System).
- 3.c) DEQ admits the averment in ¶3.c. of the Petition that groundwater sampling has been done at the Marbleton #2 landfill, but denies any other averments in ¶3.c.
- 3.d) DEQ denies that the referenced federal regulation applies to the current situation at the Marbleton #2 landfill as alleged in ¶3.d. of the Petition.
  - 3.e) DEQ denies the averments in ¶3.e. of the Petition.

3.f) DEQ admits the averments in ¶3.f. of the Petition.

DEQ further denies any other averments in the Petition to which a responsive pleading may be required.
