- 3. The Respondent shall file their Expert Designations and Reports by December 1st, 2009. The report shall state the credentials and opinion(s) of each expert and contain a detailed summary of the facts and analysis that supports each opinion.

- Depositions including Depositions of Experts and Written Discovery of Experts shall be concluded by January 25th, 2010.
- 5. Dispositive Motions shall be filed no later than February 9, 2010.
- 6. Replies to Dispositive Motions shall be filed no later than February 23, 2010
- 7. A prehearing conference shall be held, if necessary, on February 26th, 2010.
- Hearing on Dispositive Motions and Final Hearing on the matter shall be held on March 11th and 12th, 2010. The hearing shall be held in Cheyenne Wyoming.
- 9. All filings shall be made no later than 12:00 p.m. on the date set forth in this Order.
