If the Parties do not file a waiver to this section, the DEQ should pay the costs of the transcript.

- 1. The Parties shall appear for a short pre-hearing conference in this matter that will he conducted on Friday, March 2, 2012 at 4:00 p.m. via telephone conference call. Failure to appear at the pre-hearing conference will result in dismissal from this case.

- 3. The DEQ shall assume the cost of the transcript and court reporter.
