ORDER

- 1. The Parties shall appear for a short pre-hearing conference in this matter that will he conducted on Thursday, August 11, 2011 at 1:30 p.m. via telephone conference call. Failure to appear at the pre-hearing conference will result in dismissal from this case.
- 2. If the Parties have not filed a **waiver** on or before August 8, 2011 a court reporter will transcribe the hearing.
- 3. The DEQ shall assume the cost of the transcript and court reporter.
