ORDER APPROVING CONTINUANCE AND REQUEST FOR STAY

On April 24, 2012, Petitioner RAM Trucking, Inc. (RAM) and Respondent Wyoming Department of Environmental Quality (DEQ), the only Parties in this case, filed a Joint Motion for Continuance and Request for Stay of the hearing on RAM's appeal of Notice of Violation and Order No. 4899-11 issued by the DEQ. Chapter I, Section 10(b) of the DEQ Rules of Practice & Procedure provides that the Environmental Quality Council (EQC) may grant continuances for good cause shown, and Section 11 provides for disposition of contested cases by stipulation of the parties in this contested case upon approval of the EQC.

Having reviewed the Parties' Motion for Continuance and Request for Stay and being advised in the premises the EQC finds that good cause exists to continue this matter and grant a stay of proceedings as follows.


IT IS ORDERED that:

1. The pre-hearing memorandum due April 26, 2012, the pre-hearing conference scheduled for May 1, 2012, and the final hearing scheduled for May 11, 2012, are vacated and further proceedings in this case are stayed until the EQC's regular meeting on July 12-13, 2012;

2. A continuance is granted until the EQC's meeting scheduled for July 12-13, 2012 for the Parties to file either a joint stipulation for modification of the contested order and dismissal of this appeal or a proposed revised schedule for bringing this case to hearing; and

3. The EQC retains jurisdiction for the purpose of approving a stipulation by the Parties' to modify the contested order and dismiss this appeal or conducting a hearing if a stipulation is not submitted.
