**ORDER MODIFYING ORDER AND DISMISSING PETITION**

On October 19, 2011, the Wyoming Department of Environmental Quality (DEQ) issued Notice of Violation and Order number 4890-11 to G.A. Enterprises (G.A.) alleging violations of the Wyoming Water Quality Rules and Regulations (WQRR) and ordering G.A. to take certain steps to bring G.A.'s aboveground storage tanks into compliance with the WQRR. On October 31, 2011, G.A. contested the order and petitioned the Environmental Quality Council for a hearing, which the Council scheduled for July 12, 2012.


DEQ and G.A. have agreed to resolve this dispute prior to hearing, as set forth in the Joint Stipulation to Modify Order and Dismiss Petition filed with the Council.

It is therefore ORDERED that Notice of Violation and Order number 4890-11 is modified as set forth in the Joint Stipulation.

It is further ORDERED that G.A. Enterprises' Petition for a Hearing on Order number 4890-11 is DISMISSED.

Each party shall bear its own costs and attorneys fees.
