1. The Parties shall appear for a short pre-hearing conference in this matter that will he conducted on Monday, January 9, 2012 at 9:00 a.m. via telephone conference call. Failure to appear at the pre-hearing conference will result in dismissal from this case.

2. If the Parties have not filed a waiver on or before January 5, 2012 a court reporter will transcribe the hearing.

3. The DEQ shall assume the cost of the transcript and court reporter.
