The FCSWDD has considered proposals from Willowstick for groundwater mapping at the Lander and Riverton landfills. The WDEQ/SHWD and the District both have additional questions for Willowstick that we hope can be answered in a technical meeting sometime in the future.

The District does not want to expend funds or hold meetings until we have a clear understanding from the WDEQ/SHWD of what has to be demonstrated or proved in terms of unambiguous guidelines that are not subject to qualitative interpretation such that the Citizens of Fremont County can regain the use of phases 4 and 5 at Lander, and the expansion area at Riverton as "Unlined" landfill capacity for MSW.

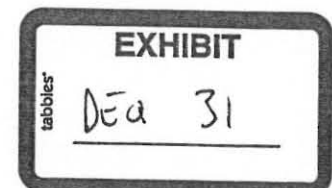
Once we have this precise information from the WDEQ/SHWD the District can find out if Willowstick's technology can provide the information.

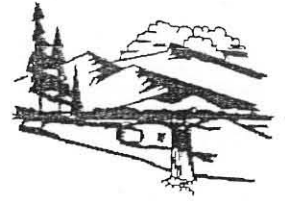

Dear Mr. Hedges:

I received your proposed schedule for reviewing the post-closure termination requests and the landfill permit renewals, dated September 13, 2005. I have determined that this is an acceptable schedule for completing the reviews. In addition, the Department is committed to completing a review of the Dubois submittal within 60 days of receipt by the Department.

In a September 1, 2005, correspondence, Dave Finley (Division Administrator) indicated that the District must submit a schedule for issues related to the groundwater investigation (please refer to the September 1, 2005, correspondence for specifics) within 60 days of that letter. On September 8, 2005, the Department attended a work session with the District during which the District proposed, and the Department agreed, an additional technical work session to discuss the specifics of the AQUATRACK® Survey was necessary prior to submitting a work plan for review. We also agreed that the technical work session should be completed as soon as possible; however, the Department has not been contacted to schedule the technical session.

While the Department has committed to make every effort to provide technical input regarding the use of the Aquatrack survey, if the technical session is not scheduled during the week of October 24<sup>th</sup>, the Department may not be able to provide technical input prior to the required submittal regarding the groundwater investigation.
