
ORDER

Fremont County Solid Waste Disposal District (FCSWDD) has filed a Request to Appear at the Petition for the Award of Fees and Cost Hearing by Telephone in the above entitled matter. The Presiding Officer having considered this request finds the following:

1. This is a unique petition that the Council rarely receives and has never been asked to consider in a SHWD permit.
2. This is a request for a substantial sum of tax revenues of the State.
3. Appearance in person by the parties' legal counsel will insure that the issue is fully and completely argued and any questions from the Council will be answered.
4. This is a very substantive issue and the Council does not want technology problems interfering with their ability to fully understand the parties arguments.

**THEREFORE**, FCSWDD's request is denied. The parties shall appear in person. The hearing will be held on May 11, 2012, at the DEQ Field Office, 2100 W. 5<sup>th</sup> St., Sheridan, Wyoming.
