## CITY OF SHERIDAN'S REQUEST FOR OPPORTUNITY TO SUPPLEMENT EXPERT TESTIMONY SUMMARY

COMES NOW The City of Sheridan (the "City"), by and through its undersigned attorneys, who make the following request:

- 1. By the Council's amended scheduling order dated December 7, 2011, the parties' designation of experts is due today, March 30, 2012 at Noon. The deadline for written and oral discovery was scheduled to be due at the same date and time.
- 2. The parties have delivered written discovery requests to each other. However, some of the responses, including the responses to the City's requests, have not yet been delivered.
- 3. As a result of the expert designations and discovery deadlines being the same time, and due to some of the discovery responses not having been exchanged by the deadline for expert designations, the City has timely delivered its designation of experts and summary of their expected testimony to opposing counsel as best it could under W.R.C.P., Rule 26.
- 4. However, the final summary included in the City's expert witnesses designations was not be as specific or comprehensive as it could have been if discovery deadlines were prior to the expert designation deadlines.
- 5. The City has discussed opposing counsel that it would supplement the scope and specificity of its designated experts after all discovery is completed and as soon thereafter as possible in an effort to timely disclose all anticipated testimony at hearing, but an express agreement among counsel as to a deadline to supplement hasn't been discussed or reached.
- 6. Therefore, the City requests the EQC for an order confirming the obligation and opportunity to complete previously-requested discovery and to supplement the scope of all expert testimony thereafter by a date certain.
