
Dear Mr. Patel:

Under Section 35-11-112(a)(ii) of the Environmental Quality Act, the Environmental Quality Council (the Council) has the obligation to approve all final orders issued by the Department of Environmental Quality (DEQ). On **October 28, 2012** DEQ issued Notice of Violation and Order **#5063-12** to you and the EQC docketed it as **#12-5211**. You did not appeal the Order to the Council. Thus, the Order became final and the Council held a public meeting on **January 10, 2013** and approved the Notice of Violation and Order **5063-12** EQC Docket No. **12-5211**.


