- 4. The Respondents shall file their Expert Designations by **Tuesday**, **July 30**, **2013**. Expert reports shall state the credentials and opinion(s) of the expert and contain a detailed summary of the facts and analyses that support each opinion.
- All depositions, including Experts, shall be concluded by Tuesday, September 10, 2013.
- 6. Dispositive motions shall be filed no later than Thursday, October 10, 2013.
- Responses to dispositive motions shall be filed no later than Wednesday, October 30, 2013.
- 8. Prehearing memoranda, including witness and exhibit lists, shall be filed and exhibits exchanged by ______, 2013.
- 9. A prehearing conference shall be held, if necessary on ______, 2013.
- 10. Hearing on dispositive motions shall be held, if necessary, on _____.
- 11. Final Hearing on this matter shall be held on _____, 2013 in
