- 3. The Petitioner shall file their Expert Designations and Reports by **Friday**, **June 14**, **2013**. Expert reports shall state the credentials and opinion(s) of the expert and contain a detailed summary of the facts and analyses that support each opinion.
- 4. The Respondents shall file their Expert Designations by **Tuesday**, **July 30**, **2013**. Expert reports shall state the credentials and opinion(s) of the expert and contain a detailed summary of the facts and analyses that support each opinion.
- All depositions, including Experts, shall be concluded by Tuesday, September 10, 2013.
- 6. Dispositive motions shall be filed no later than Thursday, October 10, 2013.
- 7. Responses to dispositive motions shall be filed no later than **Wednesday**, **October 30**, **2013**.
- 8. Prehearing memoranda, including witness and exhibit lists, shall be filed and exhibits exchanged by October 30, 2013.
- 9. A prehearing conference shall be held, if necessary on November 5, 2013 at 8:30 a.m.
- 10. Hearing on dispositive motions shall be held, if necessary, on November 7th or 8th, 2013.

- 11. Final Hearing on this matter shall be held on November 7th & 8th, 2013 in a location to be determined.
- 12. All filing shall be made no later than **5:00 p.m.** on the dates set forth above.
